New Laws 2019

The year is new and so with it comes a slew of new regulations both federal and state. Tax season is upon us and one of the many new changes involves alimony tax for those who get divorced. The new regulations will affect alimony



payments. Alimony paid will no longer be tax deductible and vice versa, alimony received will no longer be considered taxable income.

In addition, the 2018 Farm Bill removes hemp from the Controlled Substances Act, which means hemp and hemp products, including CBD, can be legally transported across state lines.

Patients are cut a break this year from those surprise hospital bills. Under the new law, patients can dispute the bill through the Department of Insurance, if they receive an unexpected bill after receiving treatment at an in-network hospital, but with an out-of-network specialist.

Here in the Valley new MVD laws increase vehicle registrations to \$32. This will go alongside the .50 cent increase to the minimum wage to \$11 per hour. These new increases will go towards teacher pay, and teacher income along with recess for kids k-5th grade will get more fresh air and exercise. Arizona will require public schools to provide at least two recess periods per day.
